Democratic reforms, entrepreneurship and its development opportunities in our country are confirmed in the works of the President of the Republic of Uzbekistan Shavkat M.M.

Entrepreneurial activity is the main factor in the socio-economic development of the developed countries of the world. Private entrepreneurship and small business are defined as the main direction of our country's economy. In the last five years, about 2,000 laws, decrees and decisions aimed at the development of this direction have been adopted. Procedures for issuing permits have been simplified, and their terms have been shortened by an average of 2 days. Redundant checks, numerous restrictions on cash, currency and raw materials have been removed. As a result of the above facilities and opportunities, new entities have increased tremendously and are developing the activities of those already working. In the last five years, the number of entrepreneurs has increased almost 3 times. Many entrepreneurs have expanded their businesses across the country, creating thousands of jobs and becoming large companies.

A class of entrepreneurs with their own reputation and brand began to appear in the domestic and foreign markets. During the dialogue of President Sh. Mirziyoyev with entrepreneurs on August 20, 2023, he pointed out 7 directions as a solution to the problems that hinder the development of entrepreneurship and small business. In particular, the first direction is business financing, the second is improving the tax system and reducing the tax burden on entrepreneurs, the third is allocating land, the fourth is infrastructure, the fifth is supporting foreign enterprises, the sixth is transport-logistics, and the seventh is order in the field. was devoted to the issues of simplification of principles, and the head of our state pointed out the urgent tasks in each direction and put forward new initiatives.

In Uzbekistan, comprehensive measures are being developed to support entrepreneurship, encourage initiative, create opportunities for them, and achieve great goals in the field of entrepreneurship. In the

According to the International Council of Small Business (ICSB), small business entities make up more than 90 percent of all enterprises, 60-70 percent of the employed, and 50 percent of the gross domestic product. 10 2023 is the year of small business and private entrepreneurship its share in the gross domestic product was 53.3 percent or 119,301 billion soums. (In Germany - 54 percent, in the USA - 52 percent, in Japan - 55 percent, in Russia - 20 percent, in Kazakhstan - 25.6 percent). The share of small business in the production of industrial products was 12.9 percent in 2000, and in 2023 this indicator reached 39.6 percent, in agriculture - 99 percent, in retail trade turnover - 88.4 percent, in the construction sector - 65.1 percent, and in investment - 32 percent. . 11 From the above statistical data, it is known that day by day small business and entrepreneurial activities are developing not only in our country but in all countries of the world.

Entrepreneurship has a great role in solving problems in the social and economic spheres and in the socio-economic development of society.
